While a small organization, we are active, respected and involved in promoting and preserving

Hamden's past.

Our Society has supported the proposed Ivesville Historic District, the Elam Ives' House nomination to the National Register, research at the Jepp Brook archaeological site and the Hamden History Library. #### **Farmington Canal Lock 14**

The CT Trust for Historic Preservation announced that a HPTAG or Historic Preservation Technical Assistance Grant was awarded to the Hamden Historic Properties Commission and its co-sponsor, the Farmington Canal Commission. This grant will be used to conduct an archaeological survey of Lock 14 which is behind the Lockkeeper's House at 3908 Whitney Avenue. The survey will include identification of structural repairs, artifacts, and cultural resources; recommendations concerning the restoration of the stonework will be presented with maps and photos. Our society is a supporting partner in this project.

Farmington Canal Lock 13 off Brooksvale Avenue near the Cheshire town line was placed on the National register of Historic Places in 1982. A few years later, the entire Farmington Canal in Hamden was listed on the National Register. Our society has been involved with his recognition and preservation effort since 1978 with our members serving on what was called then, The Advisory Committee for the Restoration of the Farmington Canal.

The Lockkeeper's house, owned by the Roche family since the 1950's was saved from the demolition and then was leased by the Town of Hamden from the CT Historic Commission in 2002. Its renovations are now complete, and we are working with the Farmington Rails-to-Trails Association to open it as a small museum dedicated to the canal's history.



#### **Financial Statement**

For your information, the Society's 2009 financial statement has been prepared by our Treasurer, Joe Pepe. On balance, income and expenses were approximately the same as 2009. There was a decline in some income areas e.g. Antiques Show due to the economy, but interest income was up due to the bequest. House related expenses included a new rear stone step and parking lot crack sealing. The Board greatly appreciates our Treasurer for his time, oversight, and sharp pencil.

#### **Summer Docents**


